Establishing an agency fund at the Community Foundation of North Central Florida (CFNCF) is a simple and efficient way for nonprofit organizations to invest their assets. The fund benefits for participation in the CFNCF's investment pools while our experienced staff helps develop planned giving programs and assists with administrative details.

TWO OPTIONS FOR AGENCY FUNDS:

- **Agency Endowment Funds** are held permanently at the CFNCF and invested for the long term. They provide an annual payout and create a permanent philanthropic resource.
- **Stewardship Funds** allow organizations to withdraw money at any time (with approval of the nonprofit's board).

HOW IT WORKS:

- The agency's board determines the type of fund needed and how much they would like to place in the fund.
- We set up the fund in the name of the nonprofit which has online access to fund activity statements.
- The fund is placed in one or more of the CFNCF's investment pools. All gains are credited to the fund.
- The CFNCF's economies of scale provide the benefits of a diverse investment portfolio and low investment fees that typically come only with very large funds.
- The agency or individual donors can add to the fund at any time.
- The CFNCF handles investment management and the administrative responsibilities so the agency's staff and board can concentrate on fulfilling the organization's mission.

- With a stewardship fund, the agency can access any amount of the fund balance at any time with a ³/₄ vote by the agency's board of directors.
- With an endowed fund, the fund is held permanently at the CFNCF and the agency receives an annual payout in perpetuity. Donors can be sure that the fund's principal will remain invested for the long term, providing a source of last support.
- CFNCF staff can **facilitate even the most complex gifts**, including gifts of appreciated stock or real estate on behalf of the agency.
- **Donors can leave a bequest** through the CFNCF to benefit your organization forever and create a personal legacy.
- The CFNCF handle investment management and the administrative responsibilities so that agency staff can concentrate on fulfilling the organization's mission.
- All funds under management are audited annually by an independent auditor.

AGENCY FUND FEES

Fees are annual and assessed monthly. The fee schedule is:

- 2.0% on first \$100,000
- 1.5% on amounts \$100,001 to \$500,000
- 1.0% on amounts \$500,001 to \$1,000,000
- .75% on amounts \$1,000,001 and above
